MERKEL CRITICIZES CLOSING OF BALKAN ROUTE

After Serbia, Slovenia, Croatia and Macedonia closed their borders to migrants over the past day, Merkel said Wednesday the Balkan nations' measures to stop the flow of migrants would be unsustainable without a broader EU response to the refugee crisis. Closing borders "is not the solution to the entire problem," Merkel said. Rather there must be an agreement among the EU's 28 members, she said.

EU PARLIAMENT SLAMS 'SULTAN' ERDOGAN ON TURKEY DEAL

European Parliament lawmakers accused the EU Wednesday of giving Turkish President Recep Tayyip Erdogan the "keys to the gates of Europe" through a migration crisis deal with Ankara.

At a summit on Monday European Union leaders agreed to work for an agreement with Turkey that would include a 'one-for-one' swap of Syrian refugees and a doubling of aid for Ankara to six billion euros.

But European Parliament Liberal group leader and former Belgian prime minister Guy Verhofstadt told MEPs in Strasbourg, France that the deal was "hugely problematic".

"It is a deal with Turkey in which we outsource our problems," Verhofstadt said.

"A deal in which we are giving in fact the entrance keys, the keys to the gates of Europe, in the hands of Turkey, of the successors of the Ottoman Empire, to Erdogan, I should even say maybe to Sultan Erdogan.

"He shall now decide on the entrance to the European Union."

Manfred Weber, the leader of the biggest group in the European Parliament, the centre-right European People's Party, said that the EU should not give a "blank cheque" to Turkey. He also condemned the "unacceptable" crackdown by Turkish authorities on the country's leading anti-Erdogan newspaper.

HUNDREDS OF THOUSANDS TURN OUT TO PROTEST FRENCH LABOUR REFORM

Hundreds of thousands rallied across France on Wednesday as students and unions protested against far-reaching labour reforms, testing President François Hollande's nerve as he tries to lower an unemployment rate that has surpassed 10 percent. The interior ministry estimated that 224,000 people had turned out to protest across France. Paris police said between 27,000 and 29,000 protesters took to the streets of the French capital while unions cited by local media put the estimate at between 80,000 and 100,000.

COUNCIL OF THE EUROPEAN UNION

• 10:00 a two-day Justice and Home Affairs Council starts in Brussels. Today, home affairs ministers will discuss the current situation concerning migration and consider possible future actions. The Council will take note of the progress on the proposal for a European border and coast guard. This would consist of an European border agency (replacing Frontex) and national authorities responsible for border management. On Friday, justice ministers will discuss the proposal for a regulation establishing an European public prosecutor's office. The Council will also take note of progress on two related directives, which are part of the digital single market strategy for Europe.

EUROPEAN COMMISSION

The European Commission has published the 2015 edition of the General Report of the activities of the European Union. The General Report covers the major events and initiatives of the year. This year, these include, amongst others, the EU's efforts to tackle the refugee crisis, the agreement on support for Greece, the EU's response following the Paris terrorist attacks and the launch of the Investment Plan for Europe, as well as other major initiatives such as the Digital Single Market, Energy Union and Capital Markets Union.
Commissioner for Employment, Social Affairs, Skills and Labour Mobility, Marianne Thyssen, welcomed the official signature by the European Parliament and the Council of the decision to establish a European Platform to tackle undeclared work. The main aim of the Platform is to reinforce cooperation between Member States in the fight against undeclared work, by exchanging best practices which could lead to the development of common guidelines and principles to help inspection authorities to tackle undeclared work more effectively.


