COUNTRIES FLASH 'YELLOW CARD' AT EU CHANGES TO CROSS-BORDER WORK RULES

A group of EU countries claimed Tuesday they had enough support to try to derail a European Commission proposal to ease wage differences between local workers and those sent abroad in the bloc.

According to several European diplomats, the national parliaments of 11 countries, including Poland, Denmark, the Czech Republic and Slovakia, have enough votes under EU rules to trigger the "yellow card" procedure against the Commission's revised new text on socalled "posted workers."

It would be only the third time the yellow card procedure has been used since it was set up under the Treaty of Lisbon. The tool gives parliaments the ability to hold up adoption of draft legislation if they consider it is aimed at something better handled at national or local level. If enough national parliaments choose to use the procedure, the Commission is required to review the text.

In March, the Commission presented a proposed revision of the EU's 1996 directive on posted workers, who are sent by employers to work temporarily in another country.

Under existing law, these workers are covered by social security rules in their country of origin, which means employers can hire workers for a lower wage in countries where welfare costs are high. But the final draft of the revised directive attempts to clarify employment conditions for posted workers and gives more detail on paying workers the minimum wage in the country to which they are posted. Instead of "minimum wage," according to the text, workers are entitled to "renumeration necessary for the protection of workers." **READ MORE**

MEPs debate and vote today on new powers for Europol. These would allow the agency to set up specialised units more easily so that it can respond faster to emerging threats. They would also set clear rules for centres, such as the European Counter Terrorism Centre that started on 1 January 2016. In some cases Europol would also be allowed to exchange information with private companies.

The decision follows weeks of protests against the proposed reform, which among other changes seeks to make hiring and firing easier for companies.

EU REFERENDUM: BCC SAYS BUSINESSES BACK REMAIN BUT GAP NARROWS

The majority of business people plan to vote for the UK to remain in the EU but the gap with those wanting to leave has narrowed, a survey suggests. The British Chambers of Commerce said 54% of 2,200 members it surveyed in April said they would vote Remain, down from 60% in February's survey. In contrast, 37% said they would vote to leave, up from 30% two months ago. Almost all of those surveyed - 90% - said they were unlikely to change their opinion ahead of the 23 June vote.

ACTING AUSTRIAN CHANCELLOR DECLINES TO RULE OUT SNAP ELECTION

Austria's acting Chancellor Reinhold Mitterlehner did not rule out a snap parliamentary election after Werner Faymann quit as head of the government, but said on Tuesday he expected to reach agreement in coalition talks with the Social Democrats. "We are not interested in early elections per se," Mitterlehner, who heads the conservative People's Party, told a news conference after a weekly cabinet meeting.

EUROPEAN COMMISSION

• The European Investment Fund signed three deals with Greek intermediary banks and funds to provide €150 million of additional investment to very small, small and medium-sized companies in Greece. Each deal is backed by European Commission programmes. The COSME agreement with Diorama Investments will trigger investments of more than €125 million to SMEs. The EaSI agreement with Cooperative Bank of Karditsa will cover a loan portfolio of €5 million for over 300 micro-borrowers targeting mainly farmers, young unemployed borrowers, cooperatives and social enterprises, as well as micro businesses active in the green economy. The European Fund for Strategic Investments-backed InnovFin deal with ProCredit group is the first EFSI deal to be signed in Greece and it will provide €20 million to innovative SMEs.

 The European Commission opened an in-depth investigation on a proposal of the German telecoms regulator to allow Deutsche Telekom to upgrade its network with vectoring technology. This phase is necessary because of the high complexity of the subject and the impact the upgrade would have for the decades to come.

GENERAL COURT OF THE EUROPEAN UNION

• The General Court confirmed that the proposed European citizens' initiative intended to promote the development of geographical areas populated by national minorities cannot be registered. The Court ruled that the proposed initiative seeks to define regions that may benefit from the cohesion policy of the EU, without respecting the Member States' internal administrative borders (T-529/13).


