Norbert Hofer of the Freedom Party (FPÖ) won 36.7 of the vote, followed by Alexander van der Bellen backed by the Greens on 19.7 percent and independent candidate Irmgard Griss on 18.8 percent, projections showed.

### **OBAMA, MERKEL PUSH** FOR TRADE DEAL AS FOREIGN CRISES WEIGH

U.S. President Barack Obama said on Sunday he would do whatever he could to advance a controversial trade deal with the European Union in his last eight months in office, but warned that time was running short.

Obama has pushed to complete two trade agreements before his term ends on Jan. 20 - with Pacific nations and with the EU - but has run into a growing swell of populist concerns about the impact on jobs, consumer protections and the environment.

"Time is not on our side." he conceded to business leaders at the Hanover Messe, a massive industrial trade fair.

"If we don't complete negotiations this year, then upcoming political transitions in the United States and Europe would mean this agreement won't be finished for guite some time."

Obama is in Germany to promote the Transatlantic Trade and Investment Partnership (TTIP) with German Chancellor Angela Merkel, but the issue was overshadowed by discussions on the crises in Syria, Ukraine and Libya when the two leaders met.

Today, they are set to hold talks with British Prime Minister David Cameron, French President Francois Hollande and Italian Prime Minister Matteo Renzi on some of the same issues.

But first, they had dinner in a 17th century palace with chief executives of some of the largest U.S. and German companies such as Microsoft, Dow, Lockheed Martin, Honeywell, BASF, Bayer and Siemens.

## **EUROSTAT: SEASONALLY ADJUSTED GOVERNMENT DEFICIT UP TO 2.3% OF GDP**

In the fourth quarter of 2015, the seasonally adjusted general government deficit to GDP ratio stood at 2.3% in the euro area (EA19), an increase compared with 1.8% in the third quarter of 2015. In the EU28, the deficit to GDP ratio stood at 2.4%, an increase compared with 2.2% in the previous quarter.

#### **EUROPEAN COMMISSION**

• The European Commission is inviting comments from interested parties on commitments offered by Paramount Pictures to address competition concerns relating to contractual clauses preventing the cross-border provision of pay-TV services. In particular, the Commission has concerns relating to clauses in certain bilateral agreements between six major film studios, including Paramount Pictures, and Sky UK under which the studios license their output of films over a certain period of time for pay-TV to Sky UK.

• More EU support is being provided to help Ecuador in the aftermath of the recent earthquake, through the EU Civil Protection Mechanism. Several EU countries are offering various kinds of support. Rescue teams and relief items are now being dispatched by four EU Member States, France, Italy, Spain, and the United Kingdom. France is deploying specialised capabilities from the European Emergency Response Capacity to help provide more than 225 000 litres of fresh water per day. The European Commission is co-financing the transport costs of relief items. An EU civil protection team, made up from experts and engineers from Austria, Denmark, France, Italy, Portugal, Sweden, Spain and the United Kingdom, has been deployed in Quito, Ecuador to help with relief efforts.

#### **GENERAL COURT OF THE EU**

• The General Court confirmed the decision of the Commission ordering the repayment of the tax exemptions granted by France, Ireland and Italy for alumina production. The Court stated that the Commission correctly applied EU State aid rules and did not infringe the principle of protection of legitimate expectations (Judgments in Joined Cases T-50/06 RENV II Ireland v Commission and T-69/06 RENV II Aughinish Alumina v Commission, in Case T-56/06 RENV II France v Commission and in Joined Cases T-60/06 RENV II Italy v Commission and T-62/06 RENV II Eurallumina v Commission).
